

EXCERPT FROM THE OPERATING RULES OF PARKING AREAS AT PRAGUE AIRPORT

The Operating Rules of Parking Areas at Prague Airport specify:

- The terms and conditions and binding rules for the use of vehicle parking areas.
- Rights and obligations of the operator of parking areas and users of parking areas.
- Fines for breach of obligations specified by the Operating Rules.

Rights and Obligations of the User

• By driving into a parking area the user agrees with the terms and conditions specified by the Operating Rules of Parking Areas at Prague Airport (hereinafter referred to as the “Rules”), that are available in their full version at www.prg.aero, at the Dispatching Centre in the Parking C building, from the parking attendant and at all automatic payment machines.

• The user shall:

- Respect the traffic signs, road traffic rules and the operator’s instructions when moving around the parking areas.
- Park the vehicle only in marked spaces.
- Secure the vehicle against theft and not leave any valuables in the vehicle.
- Keep the parking card in a safe place (do not leave it in the motor vehicle).
- Pay the parking fee for use of the parking area according to the parking area operator’s price list and leave the parking area only after inserting the duly paid parking ticket in the automatic parking system.
- If losing or damaging the parking ticket before driving out of the parking area, present an ID card and vehicle registration certificate to the parking attendant. Otherwise he shall not be allowed to drive out of the parking area and the Czech Police shall be called so the user’s identity can be proved.
- If losing or damaging the long-term magnetic card before driving out of the parking area, present the Prague Airport identification card to the parking area attendant. The operator shall check the validity of the long-term magnetic card and based on the ascertained data shall allow the user to drive out of the parking area.
- If the card is lost pay the parking area operator through the parking area attendant a fine of CZK 2,000.
- The user shall immediately report damage caused to his vehicle to the Czech Police.
- Provide compensation for damage caused to the operator – be it intentionally or through negligence.

• The user may not:

- Drive into the parking areas with a trailer without first reporting this to the Dispatching Centre by calling 220 114 022.
- Repair or wash the motor vehicle in the parking area.
- Misuse parking tickets issued by the automatic parking system, particularly by passing them on to other parking area users.

- Abuse the automatic stand for the issue of parking tickets in order to collect more than one parking ticket.
- Reverse from the arrival point at the parking area if a parking ticket has already been issued from the automatic stand.
- Use of the time delay of the lowering of the barriers at the arrival or departure point of the car park by an authorised user to leave the demarcated space without inserting his parking ticket in the automatic system (two or more vehicles passing through immediately one after the other on one parking ticket or long-term magnetic card).

Fines

If proved that the user breached any of the obligations specified by the Rules, he shall pay the parking area operator a fine for breach of each individual obligation as follows:

- CZK 2,000 for the first breach of a given obligation,
- CZK 5,000 for second breach of the same obligation,
- CZK 5,000 for each further breach of the same obligation.

The parking area operator is authorised to constantly monitor parking areas, especially the arrival point and automatic parking system at the departure points from the parking areas, and make a temporary recording, especially for the purpose of documenting possible breach of the provisions of the Rules by the parking area user.

The parking fee is set by the Prague Airport Price List which is published at www.prg.aero and is available at the automatic payment machines and from the parking area attendant.
